



# INSTALLATION INSTRUCTIONS

- STEP 1. Remove the contents from the box and check for any damage. Verify all parts against parts list. Read and understand instructions completely before beginning installation.
- STEP 2. Snap plastic retainer clips onto third wire from top of driver side and passenger side taillight guards (See Figure 1).
- STEP 3. Lift rear hatch to access taillight mounting screws located in the hatch jamb. Remove the two factory screws (one upper and one lower) that attach the taillight.
- STEP 4. Center taillight guard over taillight and adjust bracket so that retainer clip rests snugly against lens. Loosely secure taillight guard to vehicle, using #10 X 1.00" sheet metal screws provided. Carefully close hatch and make sure taillight guard does not interfere with operation of tailgate opening and closing. Adjust brackets as necessary. Tighten screws snugly using caution to avoid cracking taillight housing assembly.
- STEP 5. Remove backing tape from base of retainer clip and press firmly against taillight lens.
- STEP 6. Repeat Steps 2 thru 5 on opposite side taillight. Installation is Complete.

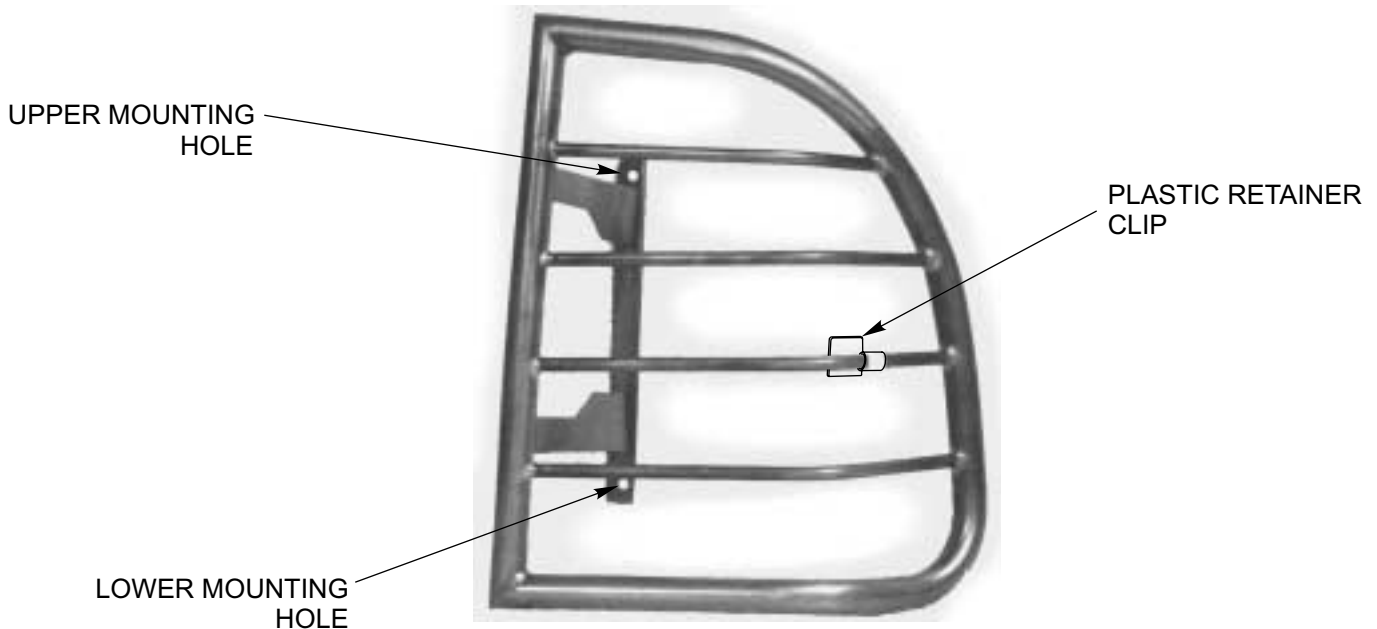
