




PROCEDURE

1. Remove contents from box, verify if all parts listed are present and free from damage. Carefully read and understand all instructions before attempting installation.

Failure to identify damage before installation could lead to a rejection of any claim.

2. Preassemble the Mounting Brackets (3-6). Do not tighten hardware at this time. See **Figure 1**.




3. Starting on the passenger side of the vehicle, locate the 3 mounting locations on the rocker panel.


Note A: The rear mounting location is shown in **Figure 2**. Other mounting locations are similar.

Note B: The lower two studs on the rocker panel have a thick coat of paint on them. When installing the M8 hex nuts, apply extra pressure to start. If necessary, back M8 hex nuts off the studs to clear build up.






4. At the rear mounting location, loosely install Mounting Bracket D (6) with preassembled Mounting Bracket C (5) using the supplied M8 hardware. See **Figures 3 & 4**.




5. At the center passenger mounting location, loosely install Mounting Bracket A (3) with preassembled Mounting Bracket C (5) using the supplied M8 hardware. See **Figures 5 & 6**.






- 6. At the front passenger mounting location, loosely install Mounting Bracket B (4) with preassembled Mounting Bracket C (5). *Note*: Installation is similar to Mounting Bracket D.
- 7. Repeat **Steps 4-7** on the driver side of the vehicle.


- 8. Secure the Plastic Cover Brackets (7) to the Mounting Brackets using the supplied M6 Hardware. See Figure 7
- 9. Fasten oval tube step bars respectively to either side using the M10 hardware provided with the step bars. See **Figure 8**.
- 10. Align and adjust the step bars as needed and fully tighten all hardware. Torque all M6 fasteners to 5-7 ft-lbs, all M8 fasteners to 15-18 ft-lbs, and all M10 fasteners to 30 ft-lbs.
