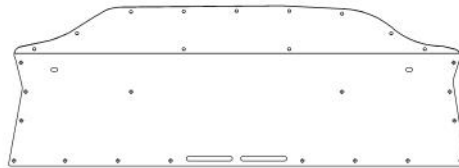

5	27	1/4" A-CORN NUT	TORQUE WRENCH

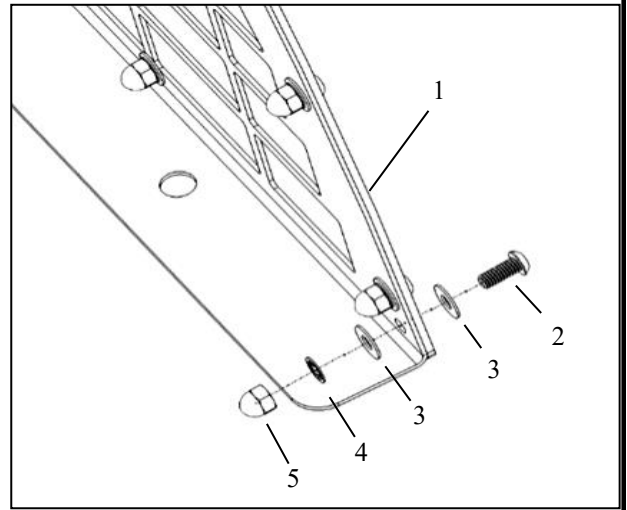
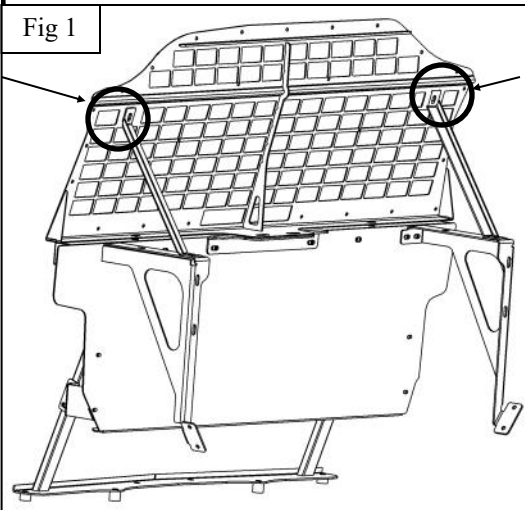

PROCEDURE

1. Remove contents from box, verify if all parts listed are present and free from damage.
Carefully read and understand all instructions before attempting installation.
Failure to identify damage before installation could lead to a rejection of any claim.
2. Note: Westin Defender Polywindow 35-120452 can be installed only in Westin Defender Rear Partition 35-12045.
3. If Westin Screen Guard is already equipped, remove the two bolts securing it to the support brackets. See **Figure 1**. Reinstall hardware after Poly Window is installed.
4. Install the Poly Window (1) using the supplied 1/4" hardware. See Figures 2 & 3. Torque 1/4" hardware to 8 ft. lb.
